Entry fee:\$750.00 per team

Deposits are due by February 1st.

First drafts of team line-ups are due by April 1st.

If your team does not pay the deposit by the due date, the spot will be given to the next up on the waiting list.

1. **TOURNAMENT FORMAT:**

- A. 5 person teams. Each team must have at least 1 woman, 1 man, and 1 senior.
- B. Each game will be a position round. Total points will determine each position; all ties will be broken by pin fall. The first round will be set by random draw for starting positions.
- C. Points will be awarded on an individual and team basis as follows:
 - 1. One point will be awarded to the winner of each individual game.
 - 2. Two points will be awarded to the winning team (based on total pins).
 - 3. Total points will determine the Tournament Champion. In the case of a tie , total pin fall we be the deciding factor.

2. **ENTERING AVERAGES:** (USBC rule 319a, item 2: “10 pin average increase” does not apply).

- a. Use 2023-2024 bowl.com high book average of 21 games or more. (Canadian Tenpin Federation rule 319f). If no 2023-2024 average, we will go back and use high bowl.com average year by year, but not past the 2021-2022 season.
- b. No sport league OR challenge league averages will be used. No summer averages will be used.
- c. If no average in previous years, we will use the current league average as of April 1st, 2025, of 21 games minimum. **If No Eligible Average, Men and Senior 225, and Women 210 .**
- d. B. Entering team maximum is 1040
- e. There is (1) one average break of 225 allowed per team.
- f. Touring PBA Members must use 230 as average with no average break.
- g. D. Failure to use correct average will disqualify a team if the correct averages make the team exceed 1040.
- h. The tournament director reserves the right to re-rate any bowler.

4. **TEAM LINE-UP:**

- A. The line-up that is submitted by the captain for the first game will be used for the first 6 games. A line up change will be allowed before game 7 (1st game the second day) and that will be the line up used for games 7-12.
- B. Substitutes must bowl in the same position of the bowler that is being replaced and must not take the team over the 1040 maximum. At all times team must comply with RULE 1a.
- C. Late bowlers will start in the frame they arrive: receiving “0” for each missed frame
